Early Morning Weddings

For weddings or events with an arrival time of 9:00 AM or earlier, the following "Early Bird" fee will apply:

Arrival time of 7:00 AM-8:00 AM \$50.

Arrival time of 6:00 AM- 7:00 AM \$100.

Arrival before 6:00 AM will be \$150 plus overnight accommodations required.

How to Book A signed contract of 30% (of your total wedding party) non-refundable and non-transferable retainer that counts towards your wedding day services are required to secure your wedding date with Beauty for Ashes Salon.

Bridal Contract Terms:

BOOKINGS: To secure a date and scheduled makeup & hair times a signed contract is required with a 30% of total wedding party services due at the time of signing. The deposit is non-refundable and non-transferable. We kindly request that each client provide electronic photos of each person worked on. Can be emailed to **beauty4ashessalon1@gmail.com**

We will also take pictures for our salon's social media and websites.

In the event that the contracted Hair Stylist is unable to perform the services agreed upon due to an emergency, illness, or unexpected occurrence a trusted substitute Hair Stylist will be assigned and informed of the contracted and discussed arrangements. **We do not accept last minute services on the day of the event.** Please make sure every person that needs service is listed on the contract. We need a certain amount of time per person to give quality service.

DELAYS: A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for a scheduled time or if scheduled makeup/hair exceeds allotted time because of client delays.

SERVICE LOCATION AND REQUIREMENTS: If hair service required please have hair washed and dried (extra services fee required). Ensure location temperature is cool and not hot so that hair will set properly. Ample lighting is also required.

TRAVEL FEE: A fee of \$50 is applied to locations at 10-30 mile radius from our hair salon. For distances outside of that radius it is a \$1 per mile fee.

PARKING FEE: Any parking, valet or toll fees must be paid by client, if applicable.

PAYMENT: The final balance is due on the day of the event prior to services if paying with Cash. For traveling services credit accepted however credit must be paid 24 hours in advance; No exceptions credit card payments will not be accepted on off site services. The Person(s) responsible for the entire balance of payment is the person(s) who has signed the booking contract.

GRATUITY: A minimum of 18% gratuity will be added to your total balance.

CANCELLATION POLICY: Cancellation must be made **14 days prior** to your reserved date or you will be responsible for the full amount of services agreed upon in this contract.

WE HAVE THE RIGHT TO REFUSE SERVICE TO ANYONE: If our hairstylist(s) feel uncomfortable, threatened or verbally abused in any way, s/he will have the right to leave the premises without completing services.

I also understand that I am responsible for balances from any members of my party who fail to provide payment.
